What is not Covered:

- Damage occurring during shipment (claims must be presented to the carrier) or general wear and tear. Damage caused during transportation of the product.

- Damage resulting from failure to follow instructions contained in your owner's manual.
- A product with a serial number which has been defaced, removed etc.
